Advertising terms & conditions

(1) Agreement between Thaivisa.com and its agent Creative Solutions Ltd. Partnership and advertising clients

(a) By using the services of Thaivisa.com and its agent Creative Solutions Ltd. Partnership you acknowledge that you have read, understand and agree to be bound by the terms and conditions set out below.

(b) Advertisement copy shall be legal, decent, honest and truthful; shall comply with all Thai Advertising standards, Laws and any applicable Code of Advertising Practice and all other Codes under the general supervision of the Advertising Standards Authority: and shall comply with the requirements of current legislation. Money paid will of course be refunded for rejected ads, but an administrative fee of 10% will be deducted.

(2) While every Endeavour will be made to meet the wishes of Advertisers, Thaivisa.com and its agent Creative Solutions Ltd. Partnership does not guarantee the insertion, the position, or the color of any particular advertisement.

(3) Thaivisa.com and its agent Creative Solutions Ltd. Partnership does not accept responsibility for any loss or damage caused by:

(a) an error, inaccuracy or omission in the publication of the advertisement:

(b) for any failure to publish an advertisement on the date or dates specified by the Advertiser:

(c) for the publication of an advertisement on the date or dates specified by the Advertiser whether the actual date be earlier or later than the date or dates specified: and/or in respect of any loss or damage alleged to have arisen through delay in forwarding or omission to forward replies to the Advertiser, however caused.

(7) Cancellations and errors must be notified immediately to our office in writing & by email.

Partnership allows 48 hours for cancellation of an advertisement placement after the emailing by Thaivisa.com and its agent Creative Solutions Ltd. Partnership to the advertiser of an advertising instruction confirmation. After that time the amounts specified in the advertising instruction confirmation fall to be paid as set out , whether or not the advertiser then pursues the campaign and placements.

(9) Thaivisa.com and its agent Creative Solutions Ltd. Partnership reserves the right to increase advertisement rates at any time or to amend the terms of contract as regards space or frequency of insertion. In such event the Advertiser has the option of canceling the balance of the contract without surcharge. If the Advertiser cancels the balance of a contract, except in the circumstances stated all unearned series discounts would be surcharged. Thaivisa.com and its agent Creative Solutions Ltd. Partnership reserves the right of surcharge in the event of insertions not being completed within the contractual period.

(10) Credit accounts are not available unless arranged prior to advertising with Thaivisa.com.

(11) Tax Receipts will only be issued by Creative Solutions after the receipt of the completed withholding tax form.
